I understand that I am obligated to complete two years of service with the North Carolina National Guard past the end date of the courses for which I am requesting funding. Failure to comply will result in a debt and recoupment to the state.

ROTC Cadets who branch outside of the North Carolina National Guard will incur a debt and recoupment back to the State. Therefore, any NCTAP funds adversely used within the last two years will be held accountable, and recouped.

I will need to maintain at least a 2.0 GPA for an undergraduate program and a 3.0 for a graduate program at the end of the semester. Failure to do so will result in a hold of NCTAP funding for the following term. Unsuccessful completion of certification/training program will result in hold of funding for the following term.

I understand that I will only received up to the capped amount of the cost of tuition only (no fees) set by my institution with the exception of NC Promise schools (FSU, ECSU, WCU, UNCP) and Community Colleges which will receive all tuition and fees.
